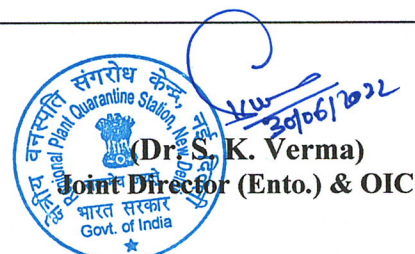

1. The Registration Certificate shall be displayed in a prominent place open to public by the fumigation agency/branch and the registration number shall be quoted in all correspondence with Directorate of Plant Protection, Quarantine & Storage and in the Fumigation Certificates being issued.
2. The fumigation agency/branch shall hold valid license for stock and use issued by the Director of Agriculture of the concerned State.
3. The certificate is valid for a period of **two years** as indicated above unless otherwise revalidated by the Competent authority. The fumigation agency/branch shall apply for revalidation at least 45 days prior to expiry of registration.
4. The fumigation agency/branch shall undertake all fumigation operations under direct supervision of accredited Fumigation Operator and abide by the conditions specified in Compliance Agreement. The fumigation agency/branch shall affix assigned mark (see **annex**) to the treated wood packaging material as per the annexure to the certificate in compliance with ISPM-15.
5. The certificate of registration granted shall be liable to be withdrawn/ cancelled, should the said firm involved in making false records or issue fraudulent certificates or failed to meet the requirements of the Methyl bromide Standard or violates any provisions of Insecticides Act, 1968 and Rules and Regulations issued there under.
